The project involves the acquisition of vacant residential properties and performing "gut" rehabilitation to these units. Many of the units are two-unit attached single-family homes or "twin houses." The project includes substantial rehabilitation of units on Park Boulevard, Kenwood, Langham, and Bradley Avenues. The sales prices for Phase II homes will be \$55,000 for the low-income units, \$60,000 for the moderate-income units, and \$65,000 for the market rate units, for which the ERB funds are earmarked. The project is expected to create one new job. PBCIP received approval from HMFA's CHOICE Program to replace the HMFA's MONI funds. The project is completed. Final documentation received and reviewed by ERB staff. ERB grant fully funded.

The CFDA, in conjunction with the Fairview Main Street, has developed concept designs for improvements in this historic area. The first phase of these improvements will include sidewalk enhancements around the park with new pavers, street trees, historic lighting with fixtures for banners, waste receptacles, and benches. The main entrances to the Square will be lighted with new historic fixtures and signage to make navigating the neighborhood less confusing. This project will supplement \$9.0 million in public/private resources used to rehabilitate 72 rental and home ownership units located within 4 buildings directly adjacent to Yorkship Square along with 2 buildings located on Merrimac Road and New Hampshire Avenue in the Fairview neighborhood. The project will result in the creation of 38 construction jobs. The project is complete and fully funded.

The funding for this project will come from the Residential Neighborhood Improvement Fund established through the "Municipal Rehabilitation and Economic Recovery Act." The CRA owns most of the land located at the project site. The CHA will serve as the developer for this HOPE VI project. Antioch Baptist Church is a partner in the project as it owns a parcel of the land and has an option agreement with the CHA to purchase other vacant property. In addition, Antioch will spearhead the senior housing component of the project. The project is expected to create 31 full-time jobs, 20 part-time jobs, and 245 construction jobs. There are 485 units that have benefited from this ERB funding, 396 units are completed and 89 are under construction. The infrastructure portion of the project has been completed and ERB funds have been fully disbursed. The balance of housing is expected to be completed by April 2011.

Pennrose is the principal of Cooper Grant Developers. CGNA has been organized and active in the Cooper Grant neighborhood for 20 years. On October 3, 2006, the ERB approved a change in the project scope from the construction of 28 market rate units to 18 new market rate units for Phase I. The ERB soft loan was reduced from \$1,550,000 to \$1,200,000 for Phase I. All of the units have been sold and the ERB funds have been fully disbursed.

The project is expected to create 35 construction jobs. The license agreement between the City of Camden and RPM is finalized. The City asked RPM to repair the sewers under the project so the budget and scope of work was revised and approved by the ERB Board. The project has been completed and ERB funds have been fully disbursed.

ERB funds in the amount of \$395,825 were committed in January 2004 to Phase II for the renovation of 11 market-rate houses. The applicant received the first disbursement in April 2005. Phase III of this project involves the acquisition and renovation of 30 rental units and 40 homeownership units. PBCIP has signed a Joint Venture Agreement with Mercy Housing and has been approved by City Council to enter into a Redevelopment Agreement from CRA for 30 properties. On February 24, 2009 ERB approved a modification to extend the term of the project to December 2010 and the scope of the work, reducing the number of units from 30 to 20 resulting in a reduction in the soft loan from \$1,160,000 to \$1,000,000. 8 units have closed with 3 more under agreement and 1 pending.

Paving, parking and site improvements will also be included, along with fencing and landscaping. The first phase of rehabilitation has been completed which includes the renovation of 53 rental units with 20 units of new construction. In addition, 35 single family homes were renovated and sold in 2004 and a second phase of single family development commenced in January 2005, which consists of an additional 35 homes. ERB funds had been committed in August 2004 in the amount of \$791,694 to assist in making improvements to 5 parking courts and other infrastructure in the Fairview section. The grant has been modified to a 1% non-amortizing, non-recourse loan for 30 years. The new loan documents have been signed and returned. All 40 units are completed and occupied. The goal of this project is to develop a pedestrian-friendly street scape in the heart of the largest commercial node in Cramer Hill. This is a highly visible area where physical enhancements have the potential to stimulate additional private investment. This project is not dependant upon the Cramer Hill Redevelopment Plan, but is complementary to the goals of the Plan. This grant request for \$659,145 in ERB assistance will help to fund the proposed improvements to Cramer Hill's Core Retail Area, which includes streetscape enhancements (pavers, street trees, historic lighting), lateral utility replacement and also road repaving along River Avenue from Cambridge Street to 24th Street. The project is complete and 98% funded. (Waiting to release retainage). On March 29, 2010, CRA sent a closeout letter to ERB confirming completion of project. Project completed under budget and CRA submitted a check for \$14,677. The grant amount has been reduced to \$644,478 to reflect the reduction in costs and \$14,677 has been added back to the Neighborhood Improvement Fund.

The project entails the construction of 162 rental units between River and Hayes Avenue in the Cramer Hill section of Camden. The infrastructure funding requested by the CRA will be utilized to engage in the acquisition activities including, relocation, demolition and environmental remediation. All properties have been assembled for Site E. This Phase includes 79 units which have been completed and rented. CRA and ERB are working with Michael's Development to submit a request for approval to amend the sponsor and project scope. On June 9, 2009, EDA Board approved the modification to the project and reduced the ERB funding amount to \$3,200,140. Of the \$3,200,140 in ERB Funding, \$900,000 will be provided to River Hayes Urban Renewal Associates as a soft loan for the 79 rental units. River Hayes Urban Renewal Associates 1, L.P. ERB soft loan for \$900,000 closed on October 19, 2009. CRA closed on the ERB grant on December 17, 2009. \$80,000 in ERB funding has been disbursed. MMA Financial, LLC, an investor, has agreed to purchase 4% Low Income Housing Tax Credits for the renovation of the low rise units in the amount of approximately \$1,102,000, which require completion of the project by December 31, 2006. The 631,725 ERB Grant will be used to fund a portion of the infrastructure improvements and the \$603,000 ERB loan will be used as permanent financing on the renovations to the 94 rental units. The applicant has experienced a number of delays in closing on its permanent financing. On 5/26/09, the ERB Members approved extension of project for an additional 90 days. The Broadway West - Phase I project is a home ownership project that consists of the gut rehabilitation of 16 units of which 14 will be market-rate units and 2 will be affordable units. The requested ERB funds will be used for the 14 market-rate units. The units will be 2-3 bedrooms, 1 ½ baths, and an average of 1,200 sf per unit. To encourage market rate housing development, the ERB may provide gap financing in the form of a soft loan of up to 40% of the total development cost. The project is complete. On February 22, 2010 Board approved an extension of the soft loan to June 30, 2010. Soft loan closed on June 23, 2010. Disbursement of Soft Loan proceeds by NJ HMFA during the construction totaled \$712,240. The \$788,971 soft loan was reduced to \$712,240 and the remaining balance of \$76,551 returned to Residential Neighborhood Improvement Fund.

The project involves rehabilitating the existing infrastructure and modifying the site conditions to alleviate and prevent the existing residential flooding. All sewer, gas and water lines are complete. PSE&G has just finished their work. Testing of these lines is now underway in compliance with City standards. All of the alleyways are done. They are now starting the site grading. Still left to do is the remaining concrete work, street paving, and fences. On October 27, 2009 Members approved a request from CFDA to extend the term of the grant agreement until October 31, 2010 and modify the budget and to amend the scope of the project in order to acquire additional vacant properties and demolishing the structures prior to transferring the properties to St. Joe's. On August 31, 2011 a request for an extension to complete the project retroactive from October 31, 2010 to October 31, 2011 was approved via Delegated Authority in order for CFDA to complete the remaining fence work. As part of the Cooper Plaza Redevelopment Plan there are 202 targeted vacant properties in need of redevelopment. 161 of those will be acquired through this ERB funding. The purpose of the \$3,584,260 ERB soft loan is to subsidize all of the 79 market rate units of this 94unit development in the Cooper Plaza Neighborhood in the City of Camden. On July 27, 2008, the Members approved a modification to the scope of the project, which increased the total number of units from 94 to 100. The Members approved a \$611,428 increase in the ERB funding, for the 53 market rate units, in order to fill the gap for the additional units and the cost for prevailing wages being paid on Phases IA and IB of the project. HMFA has requested the ERB commitment be amended to reflect certain specifications i.e., \$1,406,781 will be allocated to Phase 1B consisting of a 25 condominium unit building and Cooper Hill Housing Development will be the developing entity. An amendment reflecting these changes was approved by ERB on March 24, 2009. Ground breaking took place on June 24, 2009. Construction complete. 13 units have closed with 2 more closings pending.

Project is complete and COs have been issued. One unit closed. Remaining 9 units under contract and expected to close by end of April. The request from Oasis for an extension of the term of the soft loan until June 30, 2012 was approved through delegated authority on March 21, 2012. Upon NJHMFA approval, CFDA will oversee the work through completion at which time funds will be used to pay contractors and the appropriate NJHMFA and ERB mortgage documents will be executed by the applicants. A revolving loan fund will be set up for this program. On December 9, 2010, Project was approved by NJ HMFA Board. Program officially launched on March 31, 2011. On January 3, 2012, the City's request to shorten the term of the forgivable mortgage for program applicants from 10 years to 5 years was approved by delegated authority. NJ HMFA approved request at March Board meeting. 360 Part I applications received. 67 Part II applications received and reviewed. 39 Part II applications approved for scope of work. New Jersey Aquarium LLC (NJAL) plans to renovate and expand the State Aquarium with over 70,000 square feet of new space and more than 50 new exhibits. The aquarium expansion and renovation project consists of five distinct components with an estimated total cost of \$57 million that will require \$43 million in public funding, \$25 million of ERB funds, and \$18.0 million from the Delaware River Port Authority (DRPA).
